### **NOTICE OF FEE INCREASE TO DEVELOPER**

On March 10, 2020, the Board of Trustees approved Resolution No. 19/20-32 to increase school facilities fees to be levied against residential, commercial and industrial construction within the boundaries of the District per Education Code section 17620 effective May 11, 2020. Your proposed development is located within the boundaries of the Compton Unified School District which has passed a "Notice of Intent" to collect Developer Fees in the amount indicated below provided by Section 65995 of Government Code:

- Residential \$4.08 – sq. ft.
- Commercial/Industrial \$0.66 – sq. ft.

The fees must be paid by **CASHIERS CHECK OR MONEY ORDER (CASH WILL NOT BE ACCEPTED)**. PLEASE INCLUDE A COPY OF YOUR PLANS.

Proof of payment must be delivered to the appropriate building & safety division prior to the issuance of a building permit. Proof of payment is obtained at the following location:

Attached is a copy of the District's "Certification of Compliance" form. You are required to complete and submit the form to the District in order for the District to determine which fees are due.

The following are exemptions from Developer Fees:

- Under 500 square feet
- Retaining Walls
- Fences
- Signs
- Flag Poles
- Sheds
- Swimming Pools
- Garages
- Carports
- Unenclosed Patios
- Agricultural Building (non-commercial)
- Similar non-habitable residential accessory structures
- Tax Exempt Structure for Religious Purposes
- Private Day (Full-time) Schools
- Governmental (Structures, occupied by it)
